Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of federal and state withholding taxes due upon the 1/2/09 vesting of 11,666 of the 35,000 shares of restricted stock Mr. Ennis was granted on 12/10/07 (as adjusted for Revlon, Inc.'s September 2008 1-for-10 reverse stock split). These 4,667 withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.

2. Of these 86,331 shares reflected as beneficially owned, (a) 750 shares are unvested restricted shares that the reporting person was granted on 11/16/06, which vest on 11/16/09, (b) 23,334 shares are unvested restricted shares that the reporting person was granted on 12/10/07, 11,667 shares of which vest on 1/2/10 and 11,667 shares of which vest on 1/2/11, and (c) 48,600 shares are unvested restricted shares that the reporting person was granted on 12/8/08, 16,200 shares of which vest on each of 1/10/10, 1/10/11 and 1/10/12 (in each case as adjusted for Revlon, Inc.'s September 2008 1-for-10 reverse stock split).
