1. Revlon, Inc., the issuer, completed a 1-for-10 reverse stock split on 9/15/08 in which each 10 shares of the issuer's common stock were combined and reduced to 1 share. Accordingly, the shares reported in this Form 4 are adjusted for the 1-for-10 reverse stock split.

2. Mr. Ennis did not sell any of the 254 withheld shares. Represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of federal and state withholding taxes due upon the 11/16/08 vesting of 750 of the 11,000 shares of restricted stock Mr. Ennis was granted on 11/16/06. These 254 withheld shares are not sold on the open market and become Revlon, Inc. treasury shares. 3. Of these 42,398 shares reflected as beneficially owned, (a) 750 are unvested restricted shares that the reporting person was granted on 11/16/06, which vest on 11/16/09, and (b) 35,000 are unvested restricted shares that the reporting person was granted on 12/10/07, 11,666 of which vest on 1/2/09, 11,667 of which vest on 1/2/10, and 11,667 of which vest on 1/2/11.
