Explanation of Responses:

1. The reporting person became the counterparty to a 3-year put/call arrangement with respect to fifty percent of the equity (the "Subject Shares") of RCH Holdings One Inc., a corporation which acquired 7,718,092 shares of Class A common stock of Revlon, Inc. in 2008 for cash and notes payable to subsidiaries of MacAndrews & Forbes Holdings Inc. In connection with that arrangement, the reporting person paid \$12,015,950 to acquire a call option to purchase the Subject Shares from the holder for an aggregate exercise price of \$33,158,830 and received \$8,253,195 to write a put option obligating him to purchase the Subject Shares upon exercise from the holder for an aggregate exercise price of \$23,448,465. The transaction was effectuated to implement certain estate planning matters for Mr. Perelman.
